





Decarbonization Roadmap

As we continue to face the challenges of climate change, sustainability has become more crucial than ever.

Multiplex leverages its extensive processes, strategies, and years of experience in construction to address these challenges. Our approach is both innovative and practical, focusing on concrete steps to reduce energy consumption and promote sustainable practices through innovation. We recognize the urgent need to reduce global greenhouse gas (GHG) emissions to mitigate the devastating consequences of climate change.

In 2023 we released our Decarbonization Roadmap detailing the actions that we need to take in this decade on our path to a net zero supply chain by 2050. It outlines our strategy for transitioning from fossil fuels to clean, low-carbon energy sources, addressing goals related to GHG emissions, embodied carbon, and circular economy pathways. Our focus for 2023 was building awareness and capacity both internally and externally as well as forging collaboration with our partners in the industry.

Aligned with the United Nations Sustainable Development Goals (SDGs), we ensure that each focus area of our strategy is relevant to our business and identifies opportunities for improvement. Sustainability and responsible business practices are not only ethical imperatives but also key to our long-term success. Progress

Fuel and utility consumption fluctuate year-to-year depending on the number of our active projects and their stage of construction. Multiplex is actively exploring and implementing low carbon equipment and alternative fuels to maintain low emissions output regardless of these variables.

WorldGBC Net Zero Carbon Buildings Commitment

Multiplex commits to only owning and occupying assets that are net zero carbon in operation by 2030.

Progress

We continue to identify opportunities to reduce emissions and reach our net zero target by 2030, including purchase of Renewable Energy Certificates (REC) for electricity from renewable sources and renewable natural gas for heating.

Emissions Data

Our carbon inventory follows the Greenhouse Gas Protocol Corporate Standard and has been consolidated based on operational control. We track fuel, propane, electricity and natural gas consumption on all our sites and head office. There is an increase in Scope 1 emissions since 2020 due to fluctuation in the number and size of our active construction projects and the increased use of diesel and propane for winter heating. Scope 2 emissions are reduced since 2020 due to natural gas being supplied directly by clients and covered under Scope 3.

Onsite Water Consumption

We use water in our offices on our sites for various purposes, including: construction activities, commissioning, cleaning and dampening down dust. The reduction since 2020 is due to the number and size of active construction projects and the need for water use at the stage of construction.



This means working with clients to design out safety risks and design in safety controls in the early stages of projects, because we know we stand to have the most impact when we plan upfront.

For our people, we resource and promote programs to support their physical and mental health – from flexible working programs that are recognized as industry leading, to mental health first aid training that equips our people to support each other.

Critical Risk Workshops



These workshops bring together key stakeholders, including managers, safety professionals, and frontline workers, to collaboratively analyze potential risks that could lead to serious incidents or harm. The goal is to develop a comprehensive understanding of these critical risks, implement effective control measures, and ensure that all participants are aware of their roles and responsibilities in managing these risks. By focusing on proactive risk management, critical risk workshops help organizations enhance their overall safety performance and create a safer work environment.

Future Construction Professionals


